




<u>Bill C-65</u> defines harassment and violence as any action, conduct or comment, including of a sexual nature, which can reasonably be expected to cause offence, humiliation or other physical or psychological injury or illness to an employee, including any prescribed action, conduct or comment.












# Where and When do Seniors Bully?




Bullying is observed during :













Spiritual Abuse is any act of denying or forcing or ridiculing religious or spiritual beliefs or participation in religious services.



















### **Options**

- Advise the targeted senior that you have noticed what is happening.
   Validate that this is unacceptable and against company policy.
- You don't have to see a crisis to <u>validate</u> that someone is "going through a rough time".
- Make sure you make promises you can keep.
- If the senior is fearful, stay with them until support arrives.






























